#### **Attendance over One School Year**

- 98% attendance = less than 4 days absent
- 95% attendance = less than 10 days absent
- 90% attendance = 4 weeks absent
- 85% attendance = 5 ½ weeks absent
- 80% attendance = 7 ½ weeks absent

## Illness happens!





If your child is off school for a week with a sickness bug, it can happen, but your child can recover from this type of absence academically.



However, sporadic attendance which consists of 1, 2 or even 3 days off every week impacts your child in a very different way, it is much harder to recover from this type of absence academically.

## What a difference a day makes!

Each school year is 38 weeks
190 days at school
1 day off a week = 38 days of absence
This equates to 80% attendance overall

### Attendance 'V' Performance

Data shows that statistically if your child has 17 days of absence in an academic year it has a direct link to academic performance, reducing GCSE potential by ONE whole grade.




#### **Monitoring and Tracking Attendance**

We have a legal duty to track and monitor schools attendance. You have a legal responsibility to ensure your child is attending school and on time. If your child is unable to come to school for any reason, this is what should happen...


- 1. Parents / Carers to ring the absence line by 8:30am or send a message via 'School Comms'
- 2. If we have not heard from parents / carers we will, send a text via 'School Comms'
- 3. If we still have not heard from parents / carers we follow that up with a phone call.
- 4. We code your child's absence accordingly. This is a legal requirement for all schools to do.

We primarily use a system called Class Charts to log your child's attendance, along with behaviour, rewards and some other data. Teachers are required to register your child for every lesson, including first thing in the morning during registration. The Tutors, Heads of Year and Attendance Team regularly check and monitor the registers and follow up with any concerns.

## I / M / L / U / O - Attendance Codes

- I & M code: We do authorise absence for Illness and Medical appointments. However, we must have medical evidence for these.
- L code is considered late between 8:40am and 9am
- **U code** is considered very late after 9am. This will result in a detention and is classed against your overall attendance figures and can result in Educational Welfare Officer being involved and even a fine.
- O code is a completely unauthorised attendance, usually because we have not been informed as to why they are absent or we have been given no medical evidence. These codes can also result in Educational Welfare Officer being involved and a fine.

Fines: If a Fixed Penalty Notice is issued there is a fine of £80 per child per parent.

This can also be followed up with further legal action if not paid.

#### **Attendance Expectations**

#### What STUDENTS must do:

- Get up, dressed and ready for school.
- Access the transport options for them to arrive on time.
- Attend all lessons on time.
- Sign in separately if they are late.
- Listen to and work with parents / carers and staff to ensure the best possible levels of success.

#### What PARENTS must do:

- Try to telephone the school before 8.30am each day of your child's absence.
- Tell the school in advance of any medical appointments and bring in appointment cards/letters.
- If you are not sure whether your child is well enough to attend school, send them in anyway as they often perk up on arrival.
- Have a backup plan for if your child misses transport, call on a family member, neighbour or friend.
- If you and your child are experiencing difficulties with school attendance then talk to us as a first step so we can help!

#### What SCHOOL will do:

- Check your child's attendance every day.
- Phone home to discuss your child's attendance with you
- Invite you into school for attendance meetings if we are concerned.
- We will offer guidance and support and where necessary discuss possible interventions to help your child.
- If we cannot establish a reason for absence, then we may make a welfare visit to the child's home.
